GPS: Handler's Entrance 44°56'22.64"N, 93°42'17.00"W

Spectators: Gale Woods Farm 7210 Co. Rd. 110W, Minnetrista MN 55364

Driving Directions: From East come west on i-94 through Minneapolis. Take I-394 west exit and proceed on I-394/US Hwy12 to County Rd 15W. Follow Co. Rd 15W/ Shoreline Drive to the town on Mound. Handlers keep straight on Co. Rd 15 W at the stoplight in Mound to the Handler's entrance on left (~2 miles). Spectators turn left on to Co Rd 110W/Commerce Blvd to park entrance (~ 3 Miles).

From West, take US Hwy 12 to Co Rd15W, and then as above.
From South, take I-35 North to I-494. Take I-494 west to Co. Rd15W and then as above.

Camping

Camping is available west of the trial field. If additional camping space is needed, a second site in the valley east of the trial field is available. Handler day parking is available at the south end of the trial field east of the road. If Gale Woods is not providing shuttle service from the spectator parking lot on Sunday, we will have a limited number of guest passes for handlers to give to guests to permit them to use the Handler Parking entrance and park in handler parking.
